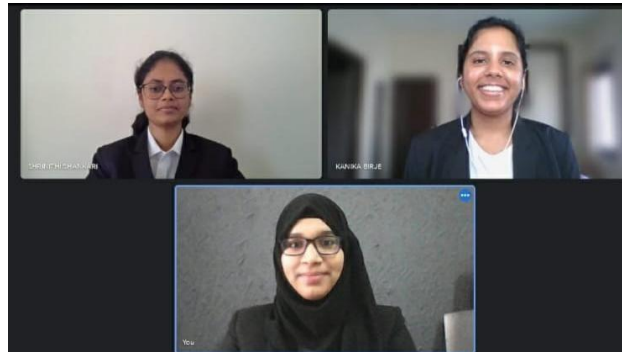
### **Assessment internship during March :-**

### **\* Moot Court Association, SLSH:**

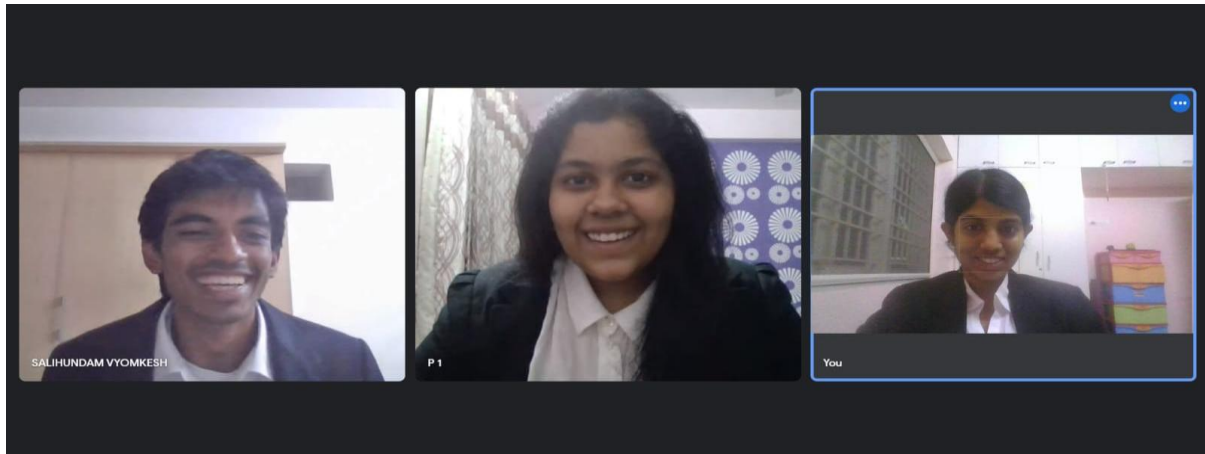

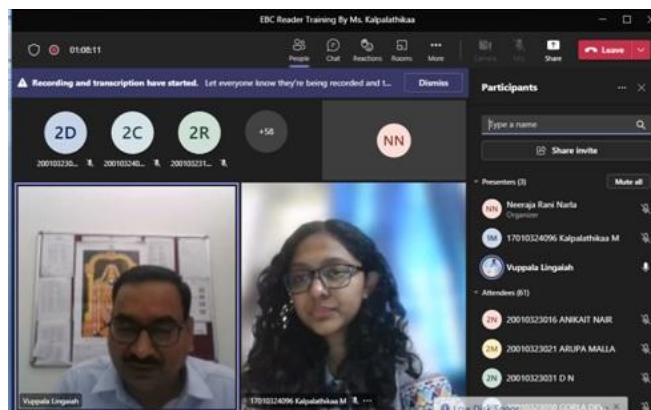
### **❖ Faculty Achievements:**
