


Workshop on Drafting of Complaint and Written Statement under Law of Torts and Drafting of Suit for Infringement /Breach of Contract (28-29 May 2015)

2 Days Workshop on Drafting of Complaint and Written Statement under Law of Torts and Drafting of Suit for Infringement/Breach of Contract – A Report

(28-29 May 2015)

Symbiosis Law School, Hyderabad invited **Ms. Savitha Sinha**, Advocate, vis-a-vis Partner, Lawfin Solutions, New Delhi on 28th and 29th May, 2015 to conduct a two days' workshop on the following topics:

- ✓ One day workshop on “Drafting of Complaint and Written Statement under Law of Torts”
- ✓ One day workshop on “Drafting of Suit For Infringement/Breach Of Contract”

Resource Person: Ms. Savita Sinha, Advocate & Partner, Lawfin Solutions, New Delhi (for both the days)

Time: 9:30 am and 5:00 pm (on both the days)

Context of the Workshop: The written word is one of the most important tools of the legal profession. Words are used to advocate, inform, persuade and instruct. Although mastering legal writing skills takes time and practice, superior writing skills are essential to success. Thus, an attempt to polish legal writing skills is envisaged through this workshop using simple tips and exercises.

WORKSHOP SCHEDULE (28th May, 2015)

Title of the Program: Drafting of Complaint and Written Statement under Law of Torts

The workshop was a full day program with five sessions viz., the inaugural session, morning session, pre-lunch session, and post-lunch session, post-tea session followed by vote of thanks to the resource person.

a. Inaugural Session

The session began at 9:30 am with the Inaugural note. The programme started with felicitation of Ms. Savita Sinha followed by a welcome address as well as introduction of the resource person by Prof M.V. Chandramathi.

b. Morning Session

The morning session introduced the students to learn the legal intricacies involved in drafting of plaint and understanding of the legal provisions involved in drafting.

c. Pre Lunch session

The morning session continued into the pre-lunch too where in a two way conversation was encouraged on legal Intricacies involved in Drafting of Written statement along with legal provisions. “*Written statement is the defense of the defendants*” was well explained.

d. Post lunch Session

The post lunch session was completely on skill building. Students were divided into group and exercises on drafting of plaint were given to the students to solve. These steps engaged the students well and were able to connect with the theory presented in the morning session.

e. Post Tea Session

This is an extension of the post lunch session wherein exercises on drafting of written statement continued. The interest of the students increased towards drafting the written statement. The drafts were analyzed by the resource person coupled with subsequent guidance to the students wherever needed.

Students understood the skill involved in drafting along with legal provisions. Since writing is the heart of legal profession—good writing results from good disciplined thinking. They were taught how to improve analytical skills and for that ‘Sometimes asking the opposite’ helps.

WORKSHOP SCHEDULE (29th May 2015)

Title of the Program: Drafting of Suit for Infringement/Breach of Contract

The workshop was a full day program with four sessions viz., morning session, pre-lunch session, and post-lunch session, post-tea session followed by vote of thanks to the resource person.

a. Morning Session

The morning session introduced the students various topics related to the provisions of Cyber Laws and Cybercrimes, provisions of Indian contract Act and Sections dealing with Breach of contract. It involved a practical orientation on how to draft a suit in Contracts stressing mainly on Breach of Contract- drafting the plaint and the written statement.

b. Pre Lunch session

The morning session continued into the pre-lunch too, where a two way conversation encouraged drafting a suit in Contracts was stressing mainly on Breach of Contract – drafting the plaint and the written statement.

c. Post lunch Session

The post lunch session was completely on skill building. Students were divided into group and exercises on drafting of plaint were given to the students to solve. These steps engaged the students well and were able to connect with the theory presented in the morning session. The students were given a problem and were asked to draft a plaint and a written statement in which the students actively participated. Then there was a discussion and query session in which the students were able to clear their doubts pertaining to the topics covered in the workshop.

d. Post Tea Session

This is an extension of the post lunch session wherein exercises on drafting of written statement continued. The interest of the students increased towards drafting the written statement. The drafts were analyzed by the resource person coupled with subsequent guidance to the students wherever needed.

Students understood the skill involved in drafting along with legal provisions. Since writing is the heart of legal profession—good writing results from good disciplined thinking. They were taught how to improve analytical skills and for that ‘Sometimes asking the opposite’ helps.




Qualitative Feedback about the resource Person




The responses are presented in a pie-charts on each parameter as depicted below:




Communication & Presentation




Aid (Slides/handouts)

Overall rating




