Promoting gender equality and empowering women is one of the Millennium Development Goals (MDGs). The standard norm has been to debate about the eroding value system in the present society for the violence against women. Absence of gender sensitization amongst the males may be attributed to the gender inequality to a large extent. The issues of violence, subordination, and inequality based on gender, needs to be addressed by significant institutions like family, educational institutions, media and work place, which play a vital role in formulating attitudes and values on gender perspectives and relations.

Gender not only refers to the physical identity of men and women, but also refers to the role they play in a society that is conditioned by various factors arising out of social, political, economic and cultural Sensitization, at this juncture contexts. because of becomes important the prevailing inequality leading to sociocultural discrimination of a single gender. This discrimination is being practiced by the members of the other gender of the same society, strongly supported and legitimized by religious and educational institutions, media, and the polity to a large extent. According to Gloria Stienem, "We've begun to raise daughters more like sons, but few have the courage to raise our sons more like daughters." The patriarchal order of Indian society continues to play an important role in the differentiated entitlements to for access to rights and resources. This attitude is hindering the growth and identity of women thus demolishing roots to social transformation. Nevertheless there are evidences of successes of women in different bastions of professional life, but they become targets of discrimination here too, in the form of glass ceiling and so on.

It is universally understood that it is the sensitization of gender in a society that can bring about a paradigm shift in the roles, rights, and privileges of men and women thus paving the way for socio-economic equality.

In a country like India, which is governed by the male patriarchical order, women suffer from multiple disadvantages. Some of the reasons for the prevailing unequal gender relations are attributed to the lack of gender



sensitization, as a result of the inherent conditioning of minds of the people. In other words, the role of the family, peer groups, and educational institutions merit attention, in terms of the creation of a sociocultural environment.

In India, gender as a social construct, continues to play an important role in translating the power relations between men and women based on masculinity and femininity; India practices power distance too which is reflected in relations between men and women at family as well as at a societal level. As Simone de Beauvoir had stated that, "One is not born a woman, but becomes one"- it is imperative that educational institutions and the civil society intervenes and contributes towards an egalitarian system which promotes gender relations and dignity, based on equality, justice and fairness.

Summary: The first speaker in the workshop started with a historical survey of the women rights movement across the globe. She attributed the origins of the modern movement for gender rights, to the A Vindication of the Rights of Woman by Mary Wollstonecraft.

She gave an account of the Indian context, wherein women in India were excluded from exercise to equal rights and power in a systematic manner – from the end of the early Vedic period. The second impact of the marginalization of women had an impact on their literacy and knowledge base with the ascendency of men, followed by a complete subjugation with the advent of the Mughals. The movement for gender empowerment witnessed the rise of people like Savithri Bai

3. WORKSHOP ON GENDER RIGHTS AND SENSITIZATION TO ADDRESS THE ISSUE OF GENDER RIGHTS AND THE RELEVANCE OF SENSITIZATION. 1st August 2015

Three speakers have been invited to share their thoughts about this topic. The first speaker:

- (ii) Prof M.V.Lakshmi Devi, Principal, Keshav Memorial Institute of Commerce & Sciences, Hyderabad discussed on *Gender Equality & Inequality A Sociological Discourse*". She stated that women in Indian have confronted unequal gender relations. She mentioned that as per law there are provisions for gender equality, but emphasized that if we want equality or don't want equality, we ourselves want inequality. In other words, she called for differentiating inequality based on biological differences from the inequality based on social constructs of gender.
- (iii) Dr. Madhusudhan Joshi, Consultant Psychiatrist gave an insight on "Gender Sensitization A Psychological Perspective". He spoke on the normative gender roles from a psychological perspective. Dr Joshi stated that our conditioning as social beings influences our biases and conformity towards sexual hierarchy.
