Profile of Mr. Ashok Ram Kumar

Mr. Ashok Ram Kumar is an Attorney with a Masters Degree in IPR (Osmania University), a Certified Mediator from BIMAC (Recognised by UNCITRAL) and has 29 years of litigation experience in IPR. He enrolled in the AP Bar in the year 1988 and initially practiced in the areas of Central Excise, Customs, FERA (now FEMA) and Corporate Law at Chennai. During this time through the Law Office of R. Sashidharan he was also associated with top law Offices in Delhi, Mumbai and Calcutta. In the year 1992 he came back to Hyderabad and joined the Office of Sri. V.V. Krishna Murthy and practiced in the areas of Arbitration, Banking Law, Corporate Law, Writ Jurisdiction Labour Law, Essential Commodities Act and Intellectual Property Law.

In 1994 was taken as adviser to then AP Govt in the area of Information Technology. In 1992-1993 he founded the oldest IP Firm in Andhra and Telangana which was called IPR CONSULTANTS and had the first IP site in AP and Telangana called IPRCONSULTANTS.COM. Subsequently the firm was renamed as WORDICTIP and the site renamed as WORDICTIP.COM.

In the year 2013, he was a founding Partner of an 100% exclusive IPR Firm "IP Markets",. As a senior Partner he deals extensively with IP litigation at every level. The Firm IP MARKETS has record for having contested and secured a favourable decree in record time of 6 months. As on date he is handling substantial cases in CR, TM, Patents, Designs and Trade Secret misappropriation at various courts in the Country. His litigation practice in courts is completely focussed around Patent, Trademark and Copyright litigation.

His passion for teaching and sharing knowledge saw him as a resource faculty at the Company Secretaries Institute (Hyderabad Chapter), Guest faculty and Lecturer at JNTU Kakinada, Osmania University; NIT's SAMETI - Dept of Horticulture; National Institute of Fashion Technology, Hyderabad; Central University; DSC (Data Security Council) - Hyderabad Chapter; the Telangana State Police Academy, Sardar Vallabhai Patel Police Academy; Law University and Colleges, **ni-msme** (National Institute for Micro, Small and Medium Enterprises) An organisation of Ministry of MSME, Govt. of India, Resource person on behalf of ESCI - The Institution of Engineers, resource person for Ecoli Mahindra College of

Engineering. He has also authored many Articles in various Law Journals, Magazines and Periodicals. In 2018 his firm along with ESCI and University of Michigan and John Cabbot University – Italy conducted a three day conference for start-ups Hyderabad called Educate to Innovate 1.0.

He also involves himself actively with start-ups as well as setting up of incubation centres in various colleges encouraging students and faculty to cultivate and inculcate practices of innovation and protection.

Mr Ashok Ram Kumar is Member of AIPPI (International Association for the Protection of Intellectual Property); INTA (International Trademark Association) and IPLPA (Intellectual Property Law Practitioners Association). He was a committee member for the AIPPI Conference held in 2011 at Hyderabad. In INTA held in May, 2015, at San Diego, USA, he is one of the few lawyers around the World to be selected to Chair a Table Topic in “Trade Marks” and represented the Telangana Bar and Country with pride. He has been selected for the INTA Law Firm Committee for the years 2016 to 2017 that was held in Orlando, USA. In the INTA 2018 held in Seattle he was the Table Topic Moderator for the topic “Trademarks and its Violations on the Internet”.

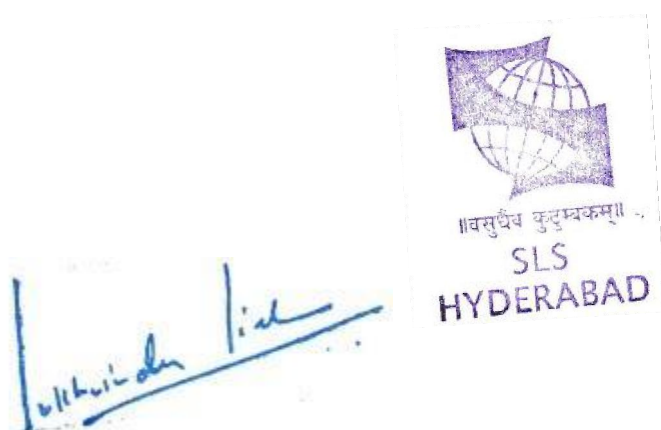

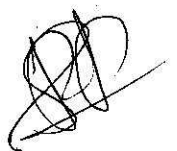
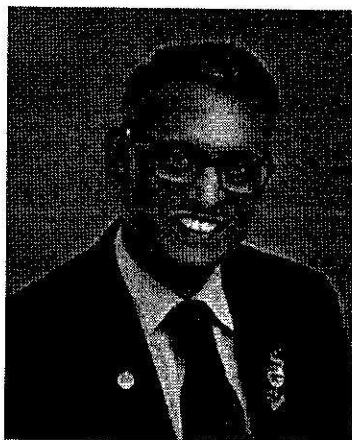

Guest Lecture On “DRAFTING A PATENT CLAIM AND PROCESS OF OBTAINING A PATENT: APPLICATION, PUBLICATION, EXAMINATION, OPPOSITION, AND GRANT OF PATENTS” by Mr. Ashok Ram Kumar, dated: 6th October, 2018

The Guest Lecture by Mr. Ashok Ram Kumar focused on a practical perspective to the students in the area of Patent Claim drafting and Grant of Patent. The basic overview of law relating to Patents was explained to the students with the help of live examples. The personal experiences of the expert in dealing with the patent drafting, patent filing and patent litigation before the Controller and the court were portrayed before the students, with emphasis on the international filing and Patent Cooperation Treaty. The Guest speaker adopted a practical based teaching method and posed real life situations before the students in order to invoke their responses, and then clarified the doubts of the students.
