

EVENT REPORT

ABOUT THE NATIONAL SYMPOSIUM

The National Symposium was organised by the Centre for Intellectual Property Research & Advocacy (hereinafter referred to as 'CIPRA') under the aegis of Symbiosis Law School, Hyderabad (SLS-H) on 11th October, 2020. The event was organized virtually through the virtual medium of Cisco Web-ex. The event was primarily organized to focus on promoting and stimulating detailed discussion in relevance to intellectual property (hereinafter referred to as 'IP'). The event was graced with the presence of note-worthy scholars in the field of IP law and boosted a great amount of participation from in-house student enthusiasts of IP Rights, along with external students and academicians. The Symposium marked a special event on every IP enthusiast's calendar since it was organized in honour of Prof. (Dr.)



Shamnad Basheer, a well renowned personality in the Indian IP climate.

The event was divided to consist of two plenary sessions and six technical sessions. The first plenary session presented qualified guests in the field of IP presenting papers on topics such

as the Role of IPR in Sustainable Development, Fair Use and Parody Rights, Innovation and Access to Medicines: The Indian Experience, the Interface of Human Rights and IPR: the Indian Perspective, Geographical Indications as a Tool for Upliftment of Handloom Weavers in India, and lastly, the Dilemma of Digital Exhaustion: Exhausting Copyright Holders in Digital Markets.

The second plenary session had speakers of great calibre cover subjects such as Geographical Indication for Economic Development in India, Introspecting Farmers' Rights under IP Regime, Trademark Litigation in India: Problems and Prospects, Exploring the Possibility of Utility Model Protection in India, and lastly, Theory & Practice of VIP Treaty in Major Economies: Evolving Jurisprudence.

- (v) Interface of Human Rights & Intellectual Property (chaired by Dr. Varsha N.Deshmukh and co-chaired by Dr. Digvijay Singh)
- (vi) Business & Intellectual Property Rights (chaired by Dr. Shilpika Pandey and cochaired by Ms. Aakanksha Kumar)

guiding research in health policy and pharmaceuticals.

Dr Surya Mani Tripathi is the Legal Counsel at ICRISAT Hyderabad, India. He is an international lawyer, registered Indian attorney and Registered Technology Transfer Professional (RTTP), accredited by ATTP. He was instrumental in establishment and sustainable operations of Intellectual Property Facilitation Cell (IPFC) and WIPO's Technology Innovation Support Center (TISC) at AIP-ICRISAT.
