

About the Seminar

Millions of human beings particularly women and children have been trafficked from one place to another. It is a trade which involves the buying and selling in human being for the purpose for forced labour which could include: domestic servitude bonded labour, commercial sexual exploitation, forced marriage, forced surrogacy, organ trafficking. It is the worst forms of human rights violation. It induces deep physical and psychological trauma to the victims of trafficking. It reduces victims to mere "commodities" to be bought, sold, transported and resold. Victims of human trafficking suffer isolation and separation from families and communities, sometimes in places where they have no legal status or do not speak the language, make trafficked victims especially vulnerable to exploitation by unscrupulous employers.

Therefore, the conceptualization of the phenomenon principally lies in the elements of 'force', 'coercion', 'deception' 'lack of freedom, choice and agency'. Any recruitment which involves any of these elements therefore qualities as an act of human trafficking. Further, women and children are disproportionately affected by the phenomenon of human trafficking. They are one of the potential victims of sex trafficking. It is the form of human trafficking which has been historically addressed both by national and international legal instruments. It is the first form of trafficking that was identified and addressed by legal instruments. Further, significant efforts have been made to address and combat the problem of human trafficking.

Poverty, unemployment, political turmoil, natural calamities, conflicts are some of the primary causes that results in trafficking in human beings. These selling and buying of human beings as lucrative merchandise henceforth results in serious loss of self of the trafficked individual. It gives to physical and mental suffering the victim of trafficking.

Therefore, to encapsulate the complex phenomenon of human trafficking requires contextualization, examination and analysis. Comprehensive research findings are one of the primary ways to address the problem of human trafficking. Research on human trafficking would enable designing and drafting efficient anti-trafficking mechanism. Although robust legal mechanisms exist, however the problem is persistently increasing at a higher rate.

The discourse on human trafficking consists of various theoretical and practical approaches. These approaches require critical, analytical and feminist analysis. Therefore, keeping this in purview the present seminar would call for papers which would be based on field as well as the available literatures human trafficking.

Themes

The primary objectives of the Seminar are to, conceptualize and critically analyze the various dimensions of human trafficking. Some of the themes under which the seminar will be organized as follows,

PROFILE OF THE INVITEES

1. Chief Guest: Rtd. Justice Nadira Patherya:

Born on November 19, 1956. Passed B.A. and LL.B. from the University of Calcutta. Was enrolled as an Advocate on June 6, 1983. Practised mainly in the High Court at Calcutta and also in the Supreme Court of India, High Court of Orissa, High Court at Patna and High Court of Jharkhand. Practised in Civil, Labour, Company, Arbitration and Constitutional matters. Specialised in Civil and Constitutional Laws. Was elevated to the Bench of the High Court at Calcutta as a permanent Judge on June 22, 2006.

2. Guest of Honour: P.M. Nair, IPS:

IPS Former Director General, National Disaster Response Force & Civil Defence, Govt. of India.

Dr. P M Nair, IPS (Retd), is the former Director General, National Disaster Response Force & Civil Defence, Govt. of India, New Delhi, Dr. Nair has handled several crimes including Rajiv Gandhi's assassination, International Arms Drop at Purulia, Sanjay Ghose abduction etc.. Dr. Nair served the National Human Rights Commission as its Nodal Officer, Anti-Human Trafficking. As Project Coordinator, Anti-Human Trafficking, with the UN Office on Drugs and Crime (UNODC), New Delhi, Dr. Nair carried out training of more than 11,000 police officials and prosecutors across India and set up nine Anti-Human Trafficking Units

3. Guest of Honour: Dr. Gangotri Chakraborty:

She is presently working as a Professor of Law, University of North Bengal. She won award for Academic Excellence given by Society of Indian Law Firms & Bar Association of Supreme Court, 2009.

Special Guest: Mahesh Bhagwat, IPS, Commissioner of Police

Mahesh Bhagwat who currently serves as the first Commissioner of Police of Rachakonda, a police commissionerate in India's Telangana state that covers more than four million residents, has demonstrated remarkable commitment to the fight against human trafficking for the last 13 years. He has participated in anti-trafficking operations that have removed hundreds of victims from situations of trafficking and, with the help of other government departments and civil society organizations, has ensured their placement in support programs.

Mr. Bhagwat's dedication to the fight against human trafficking is exemplified by his innovative and highly effective approach to investigating cases and his success in dismantling trafficking operations within his command areas. He has pioneered the use of legal provisions to close sites where human trafficking is known to occur. Under his command, Rachakonda police closed 25 brothels—five hotels and 20 residential apartments—in less than a year and participated in one of the largest crackdowns on labor trafficking in the country, which led to the identification and removal of more than 350 children forced to work in brick kilns. In addition to being a central figure in trafficking deterrence efforts, Mr. Bhagwat also constantly pushes for human trafficking to be a top priority for the Telangana state of India.

4. Special Guest: Dr. Geraldine Forbes

Professor Geraldine Forbes is a Distinguished Teaching Professor at the department of history, State University of New York Oswego. Professor Forbes earned her B.Ed. from the University of Alberta. She earned her Master's degree and Ph.D. in history from the University of Illinois. Professor Forbes began her research in Bengal over three decades ago. Her first book, "Positivism in Bengal" was selected for the Rabindra Puraskar. She has extensively written on history and lives of Indian women. Her publication includes "Shudha Mazumdar: Memoirs of an Indian Woman" (1989), "Manmohini Zutshi Sahgal: An Indian Freedom Fighter Recalls her Life" (1994), "Women in Modern India" (1996), for the New Cambridge History of India, and "Women in colonial India: Essays on Politics, Medicine and Historiography" (2005). Her most recent book, "Because I am a Woman": Child Widow: A Memoir from Colonial India" (2010), with Tapan Raychaudhuri, is the translated and edited memoirs of Hamabati Sen.



5. Key-note speaker: Ruchira Gupta:

Ruchira Gupta is a writer, feminist campaigner, teacher, and community organizer of women across the world and particularly in red-light areas and in caste-ghettoes suffering from inter-generational prostitution in India. She is the founder of ApneAap Women Worldwide (www.apneaap.org), a grassroots movement to end sex-trafficking in India. She has designed and teaches a course on human trafficking at New York University. She writes columns for The Telegraph, Outlook, The Guardian, CNN, New York Times, Hindu and Jansatta. She has won an Emmy for her documentary, The Selling of Innocents and the Clinton Global Citizen Award for her work to end sex trafficking globally. She has testified to the United States Senate for the passage of the Trafficking Victims Protection Act, addressed the UN General Assembly on human trafficking for the creation of the Trafficking Survivor Fund, and this past year she was instrumental in the passage of India's new anti-rape laws that also criminalize the process of trafficking, the first of its kind in her country. Gupta began her career as a journalist, working for The Telegraph Newspaper (Kolkata, India), The Sunday Observer (Kolkata, India), Business India Magazine (Delhi, India), and British Broadcasting Corporation (BBC) South Asia (Delhi, India). During her journalism career she extensively covered women's rights, armed struggles in the north-east of India, caste conflict, and minority issues. She continues to write extensively on sex trafficking and women's rights issues for Open Democracy, Pass Blue, CNN, Times of India, The Hindu, The Guardian, among others. She then moved on to the United Nations, where she worked with the governments of Iran, Nepal, Thailand, Cambodia, Laos, Vietnam, Myanmar, Indonesia, Kosovo, and the Philippines. She supported some of these countries to develop National Action Plans and laws against human trafficking. She has written two manuals on combating trafficking for law enforcement and supported by UNODC and UNIFEM. Gupta also a UNICEF contact in October 2000 for the first-ever gathering of Messengers of Peace and Goodwill Ambassadors.




Report on the National Seminar on "Discourses of Human Trafficking: Reflections on various perspectives" conducted on 8th and 9th February 2020

The very first Plenary Session of the Two Day National Seminar took place on the 8th of February, 2019 at 1:30 pm. The session was kickstarted by the Director of Symbiosis Law School, Hyderabad Prof (Dr.) Sarfaraz Ahmed Khan, who presented his paper which focused on the ideology and the rhetoric behind the Nirbhaya gangrape case. He spoke of the system that had allowed such an incident to happen and the mindset of the perpetrators, that paves the way for not just such incidents but also plays a part in the proliferation of human trafficking. The next presenter was Prof (Dr.) Gangotri Chakraborty from West Bengal, who emphasised mostly on the incidence of human trafficking in Bengal, especially Kolkata. The third speaker was Dr. P.M. Nair, a retired IPS Officer who has dealt with several cases such as the Rajiv Gandhi Assassination. The topic of his research paper was "Victim Damage Assessment on Human Trafficking Crimes and its Role in the Criminal Justice System: A Victimological Understanding" and he spoke about the depths that human trafficking has reached in our every day lives and the surprising places where it has managed to spread its poison. Then Prof (Dr.) Geraldine Forbes from Emerita Department of History, State University of New York, Oswego spoke about human trafficking from the perspective of a historian and gave a detailed background of the topic. The final speaker of Plenary Session I was Meera Raghavendra who is the Director and Secretary, Women's Initiatives. She ended the session by talking about police action in helping to tackle human trafficking and the challenges and prospects ahead. The next session was a technical session where participants from around the country presented their paper on human trafficking and gave their insights on helping to resolve the issue.



The second Plenary Session on Discourses of Human Trafficking: Reflections on Various Perspectives took place on the 9th of February at 9:00 am. The session was opened by Prof. (Dr.) Rekha Pande from the University of Hyderabad, who presented her paper on Trafficking and Commodification of Women's Bodies for Sex Work – A Case Study from Telangana. As the name suggests, she focused her presentation on human trafficking in the state of Telangana. The next presenter was Prof. (Dr.) Shamita Sarkar from Vidyasagar University who spoke about women trafficking in Bangladesh and also about the border line perspective and predicaments. She was followed by Dr. Sawmya Ray who is an Associate Professor at IIT, Guwahati and she spoke about gender bias in Assam and how people's stereotypes had strengthened the human trafficking network. Her paper was titled Interrogating Heteronormativity, Reconstructing Reintegration: Narratives from lives of women in Sex Industries. The next presenter was Prof. (Dr.) Ajailiu Niumai from the University of Hyderabad, who gave a detailed insight on various incidents of human trafficking. She narrated many stories to give a human perspective to the issue. The sixth speaker was Dr. Nilanjana Ray from TISS, Hyderabad whose paper was titled Child Trafficking and Abuse: Moving from Offline to Online. She spoke about the effect that human trafficking has on the children and the difficulty of integrating them back into civilised society. Then, Dr. Sharon Menezes who is an Assistant Professor at TISS, Hyderabad whose paper was titled Women, Families and Communities Trafficking: Uncovering Stories of Distress, Crime and Resistance and gave the impact that human trafficking has on the families of the victims. The last speaker was Ms. Claire Adionyi from Strathmore Law School who her perspectives on human trafficking. She not just focused on India but also focused on her home country Kenya.

Following this, the two Technical Sessions took place where the participants continued to present their papers on human trafficking. The event was ended by a Valedictory ceremony, where the guests were thanked for gracing the event with their presence. Then, various prizes were given to the best presenters of each session and the ceremony ended with Dr. Priyanka Mohod giving the Vote of Thanks.
