Session 3- Due Diligence & Investor awareness	The third session of the day dealt with the importance of due diligence in capital markets and also the risks associated with their assets and the manner in which they can be curtailed.
Session 4- Overview of the Bond offering process	The final session of the first day of the workshop dealt with providing an overview of the concept of bond offering and manner in which it is conducted in the international market.
