Tangible tips which shall assist the students in penning down an effective Statement of Purpose and linking their interest with what University has to offer.

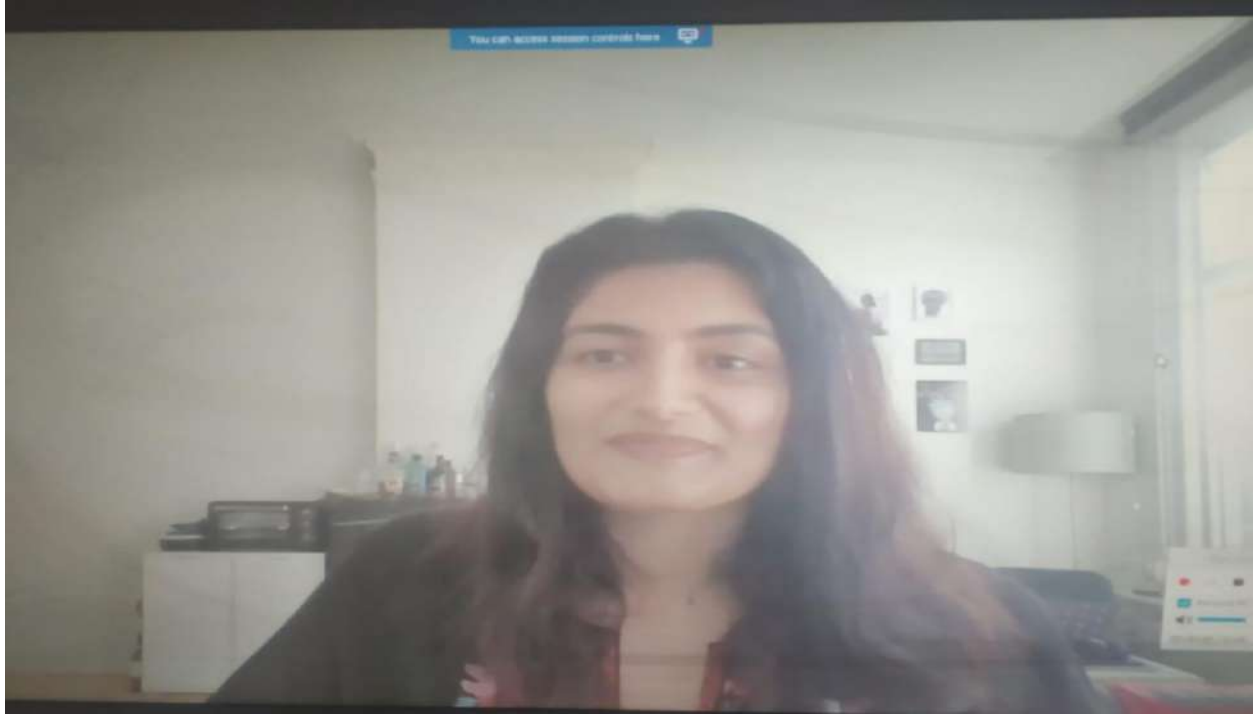
Outcome of the webinar:

The webinar on approaches to higher education turned out to be a great success. The session was really insightful and informative for the students who attended it. Students had asked multiple



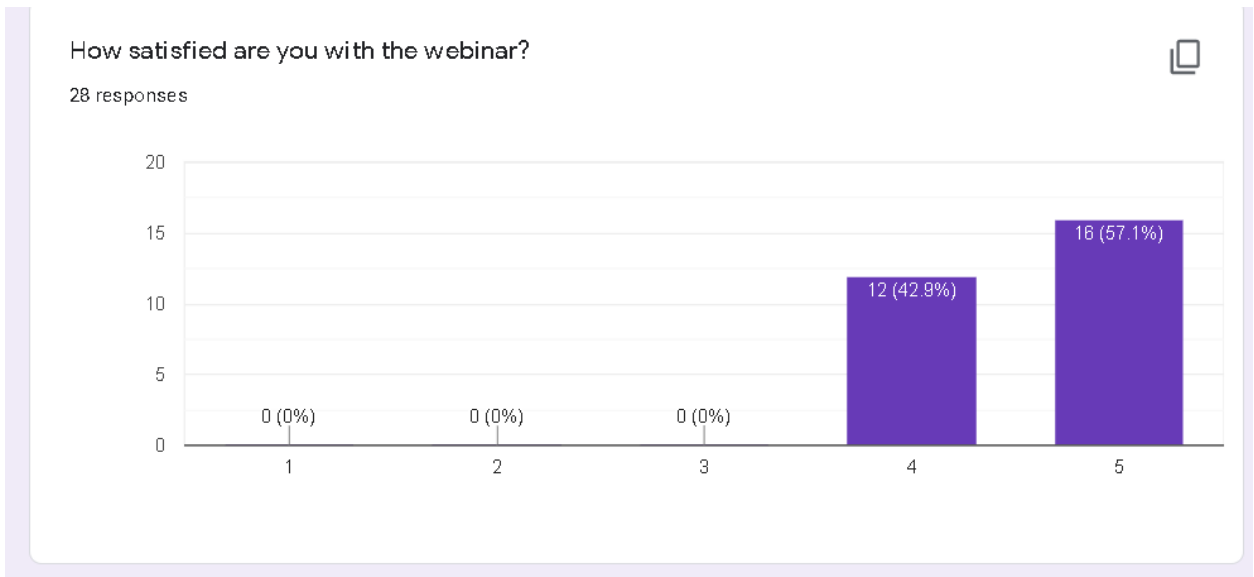
questions to the resource person which was clearly answered and cleared. The session motivated many students to pursue higher education after their LLB courses

Deliberating on how the skill of CV writing and cover letter is not just about securing a job but is also a skill about how you present yourself.

Emphasizing on CV acting as first interaction and formal communication with potential recruiter and the relevance of possessing such writing skill for law students.

Pointing out the mistakes that most of the law students make while drafting their CVs

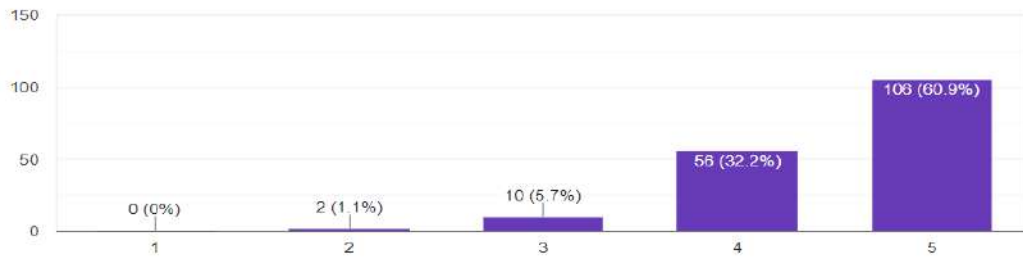
A detailed insight into the skill sets that potential recruiter of law firm would look for and discussing several reasons for CV without getting due consideration getting rejected.

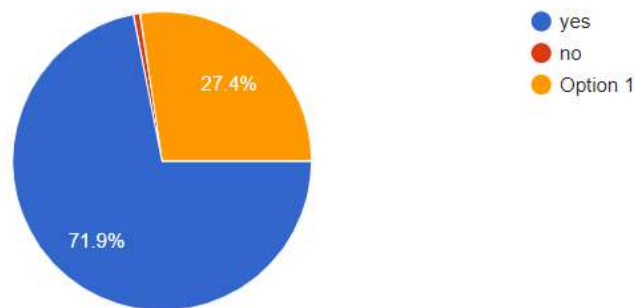
How satisfied are you with the resource person?

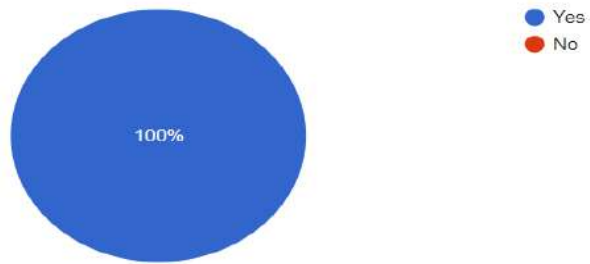

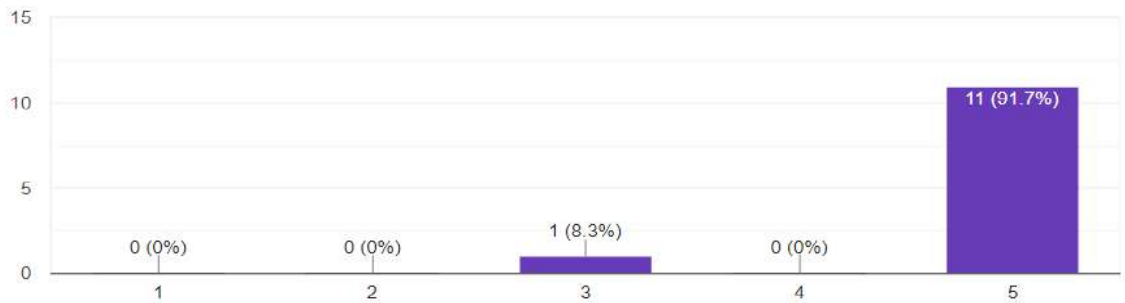
