Moot Orientation Programme, 2022



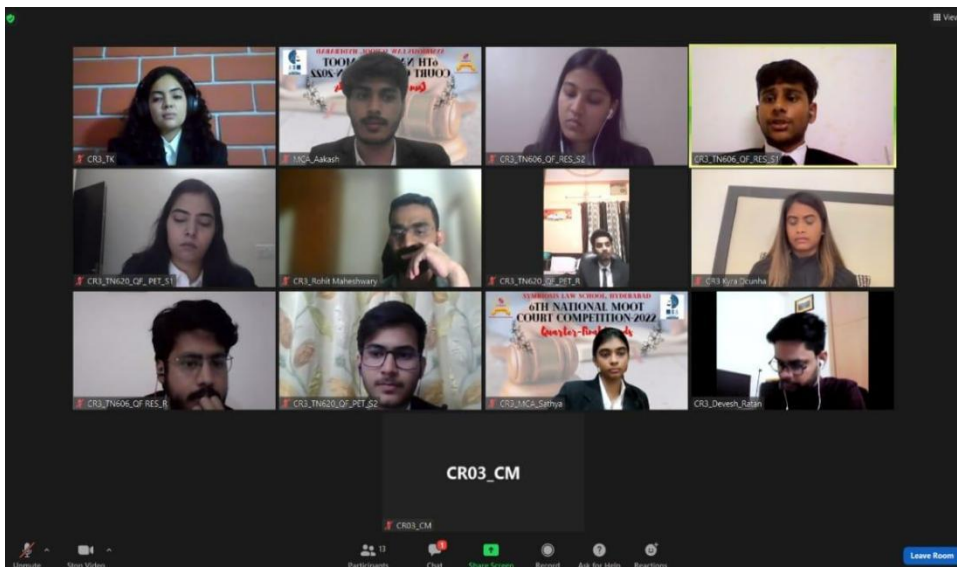
