#### 1. Dr. Sudhir Jain

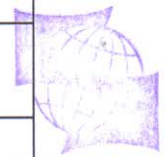

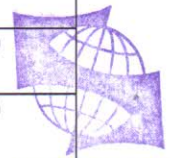
