1. Workshop on Legal Report Writing:-

2. Guest Lecture on the topic "Sensitization on Prevention of Sexual Harassment" on 06th December 2022.

To create awareness among aspiring youngsters and staff, a Guest Lecture on the topic "Sensitization on Prevention of Sexual Harassment" is conducted in collaboration with Symbiosis Institute of Business Management, Hyderabad and Symbiosis Centre for Management Studies, Hyderabad. Ms Kamaxi Sambari & Dr Rama Devi Gudemela, Member of the Child Welfare Committee, Department of Women and Child Development, Telangana State, were invited as resource persons for the event.

Dr Rama Devi briefed about sexual harassment at women's workplaces and focused on the prevention, prohibition and redressal of these issues as per the act 2013. She spoke on how the policy works and its implications at the workplace. Ms Kamaxi Sambari discussed the POSH law and described its implications for women in the workplace.



3. Nukkad Natak on "Prevention on Sexual Harassment" on 7th December 2022

SHAKTI, the Women Development and Social Responsibility Cell of SIBM Hyderabad, SCMS Hyderabad and SLS Hyderabad in collaboration performed a play to bring out a thought-provoking message on the 7th of December 2022. 4. Visit Judge Tiffany Williams Brewer to Symbiosis Law School, Hyderabadon 12th December 2022

On 13th December 2022, Symbiosis Law School, Hyderabad(SLSH) had the pleasure of inviting Judge Tiffany Williams, Assistant Professor, Howard University School of Law, Washington, D.C., to the campus to address the students and Faculty Members of SLSH. She addressed the students in two sessions. In her first session, Judge Williams spoke about the intricacies and complexities of approaching a moot court competition. She explained the necessary skills required in drafting a memorandum and how to plead the arguments on the day of the competition. Judge Williams

pressed on the need for the ideas to be as persuasive and, simultaneously, as logical as possible. She conducted an interactive session that was also intellectually essential for law students, especially first-year law students who were in the majority of the audience. She included anecdotes from her career to make the talk more comprehensible.



The second session focused on comparing the Constitutions of India and the USA. Judge Williams spoke about the various similarities and differences in the leading sources of laws for both countries. The US Constitution is much shorter, with a more significant focus on creating a solid federal character, than the Indian Constitution. She conveyed the need for students to be aware of Constitutional issues worldwide.



Ms. Tiffany Williams conducted a Faculty Development Program for faculty members of SLSH on the topic of Advancing Interdisciplinary Academic and Research Approaches in her third session. Madam explicitly highlighted the need for perspectives on areas which are necessarily blooming from the researcher's own experience and the importance of externalizing personal events and incidents and presenting them as one's voice, thus serving the most significant purpose of researching, which is advancing knowledge. The session also highlighted the interdisciplinary research requirements in the field of law and the need for the same.



5. Movie Screening on 15th December 2022:

The Telugu film 'Geometry Box' directed by Mr. Sainath Ponna was screened on 15th December 2022 in the Auditorium of Symbiosis Hyderabad campus, in collaboration with Cultural Troupe and Movie Club of Symbiosis Law School, Hyderabad, Symbiosis Institute of Business Management, Hyderabad and Symbiosis Society, Hyderabad campus.
