1. INDUCTION WEEK FOR BATCH 2023-28 (JULY 10 TO JULY 15, 2023):-

Introduction:

The Induction Week for the batch 2023-28 at Symbiosis Law School Hyderabad (SLS-H) commenced on July 10, 2023, and concluded on July 15, 2023.
