### 10. UGADI



#### 13. A one-day capsule course on "Entertainment Laws: Licensing and Regulation"



He briefed the audience about the rights that filmmakers, actors, and producers possess, including promotional, broadcasting, and marketing rights, and provided an overview of the Copyright Act and Music Rights. He focused mainly on the practical applicability of entertainment laws.

The second session was held online, and the speaker was Mr Siddhant Jhamb, Associate at VMH & Associates. He explained the technicalities involved in addressing disputes in the entertainment sector, the basics of drafting agreements, and discussed career opportunities for students engaged in this field."

Additionally, a discussion on the enforcement of the Emergency Arbitral Award vis-a-vis section 17 of the Arbitration and Conciliation
