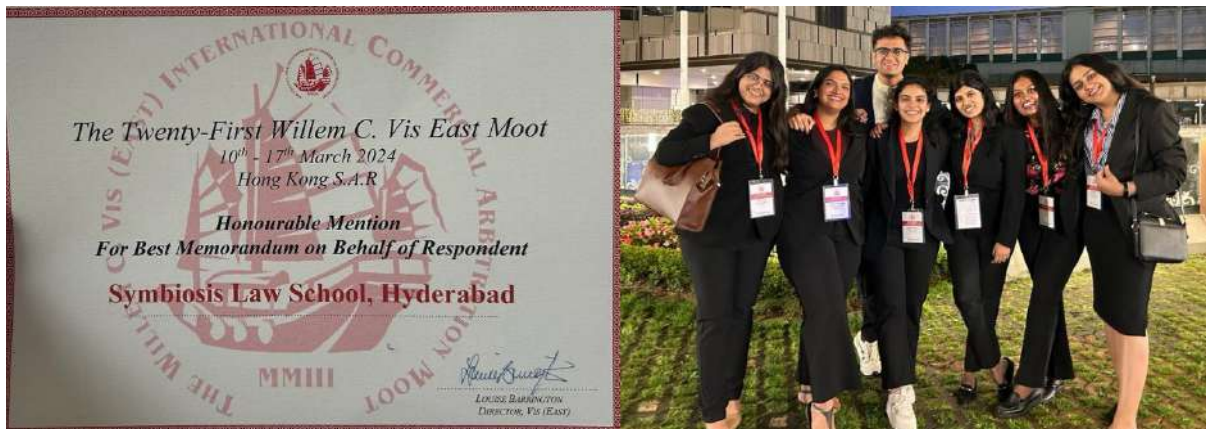

## **Workshop: Contemporary Challenges in Immigration and Migration Law:**

### **Navigating Global Perspectives**

On March 15th, 2024, the Center of Specialization in Immigration and Citizenship Laws conducted a one-day workshop titled "Contemporary Challenges in Immigration and Migration Law: Navigating Global Perspectives." The workshop aimed to explore critical issues in immigration and citizenship laws by inviting Dr. Hemangini Chandra Sharma, Assistant Faculty at NALSAR, Hyderabad, as the guest speaker.
