The speakers for the seminar included Ms. Aparna Gaur, Leader of IP and TMT Practice at Nishith Desai Associates & Ms. Dhrumi Gada Chief Minister's Fellow, Maharashtra Cyber Department, Home Ministry. Issues associated with Augmented Reality (AR), including intricacies related to intellectual property rights in the AR space and various lacunas in the data protection regime, and differences between AR and VR, along with discussing security and privacy challenges, were discussed in the webinar. The webinar provided perspective on

challenges in the AR and VR space, along with insightful solutions to address these lacunas for a strongly regulated regime in cyberspace.

"Anything but a Backpack day" was organized by the cultural troupe of SLSH on 12th October 2022. Students across batches brought their books in many household items besides a bag.




7. Quiz competition, "Cybuzz - Opportunities and Challenges of Cyberspace in the Modern Age."

The speaker introduced and briefed about the fundamentals related to insurance laws, natural catastrophe risk factors, and Office Protection Shield Policies.



11. 2 - Day Workshop on "The RTI Drive"

The Centre for Finance, Accountability, Corporate Governance & Transparency (C-FACT), SLSH conducted a 2 - day workshop on "The RTI Drive" on the 18th and 19th of October, 2022. Mr. Srinivas Madhav, Sr. Professor at Dr. Marri Channa Reddy Human Resource Development Institute of Telangana's Centre for Public Administration(MCRHRDIT), Advocate Akhil Ennamsetty, Practioner at Telangana High Court, was invited as speakers. Speakers spoke about the RTI Act & PIL in India and its meaning, scope, relevance, applicability, origin, extent, landmark cases, and access to justice. The event was productive and interactive.



12. Field Trip:-

A field trip to Hyderabad for Court Visit & District Consumer Disputes Redressal Commission was organized for the students of batch 2019-2024 as a part of their curriculum to understand the working of a court and the nature of duties of the judicial officers. The visit was to help the student understand the role of the Court in dispensing justice in any case, the part of prosecutors in a case, the way cases proceed in a court, the way judges, prosecutors, and defense lawyers handle the case, the relationship of the prosecutors and the police. The field trip was an opportunity to understand the need for coordination in the justice system. The visit included an in-depth study of the day-to-day functioning of the Civil and Criminal Courts at different levels and over a wide variety of cases. The aim was to evaluate the available resources and the power distribution between the judges, the prosecution, and the defense counsel. The students visited different Court Rooms and observed Court Proceedings, followed by a visit to the Consumer Commission situated in the surroundings of the Court. Similar to the purpose of the Court visit, this visit helped students understand the working of a Consumer Commission and the role played by the designated officers and other employees to allow the commission to discharge its functions of dispute redressal. The students, during their visit, witnessed complaints against unfair contracts, amongst other listed matters.



GUEST LECTURE SERIES:-

- A Guest lecture, Civil Law Practice, was conducted for the students of batch 2019-24
 on 1st October 2022. Ms. MSLK Srutha Keerthi, practicing Advocate at the High
 Court of Telangana and City Civil Courts, was invited as the guest speaker. The
 Speaker discussed various aspects regarding transfer petitions, provisions relating to
 setting aside abetment, etc., and relevant cases.
- 2. A Guest lecture, Corporate Law Practice, was conducted for the students of batch 2019-24 on 13th September 2022 & 24th September 2022. Ms. Lalitha Devi, CS, a fellow member of the Institute of Company Secretaries of India, was invited as the guest speaker. The Speaker discussed various aspects of the "Employer-Employee relationship" and highlighted multiple law provisions relating to Sexual Harassment at Workplace.
- 3. A Guest lecture, Corporate Law Practice, was conducted for the students of batch 2019-24 from 6th October 2022 to 8th October 2022. Ms. Aparna Devendra Wagh, Legal Head of Corporate Legal and Secretarial Practices at SNM & Associates, Bangalore, was invited as the guest speaker. The Speaker discussed the process and procedure of Due Diligence in different corporate settings and the intricacies involved in carrying out Due Diligence.
- 4. Guest Lecture on "Insolvency and Bankruptcy Laws: The Road Ahead Issues and Challenges" organized by training and placement cell on 15th October 2022 by inviting speaker Advocate Amir Bavani Founder, AB Legal. Speaker briefed basics procedure of insolvency and bankruptcy and the need and development of such laws in India. And also, the need for separating insolvency and bankruptcy from the Companies Act 2013, and thereby enacting separate legislation, i.e., the IBC, 2016, and its relevance in today's modern world by clarifying arising doubts with real-life practical case laws related to the IBC, were discussed.
