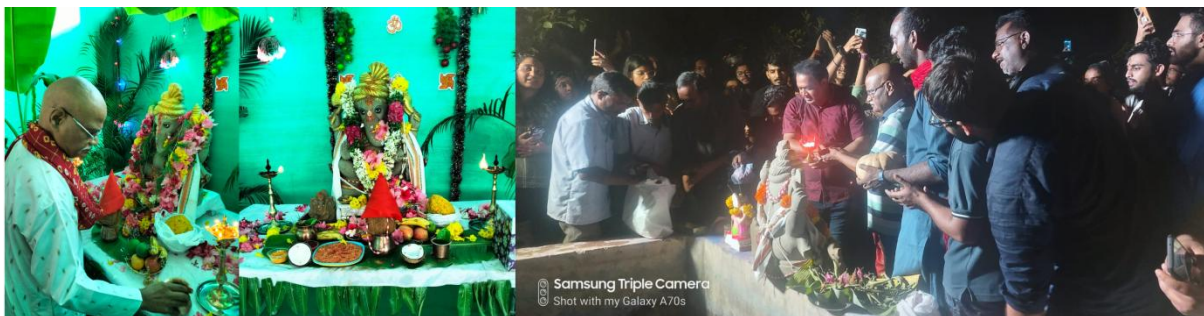

15. Saraswati Poojan -

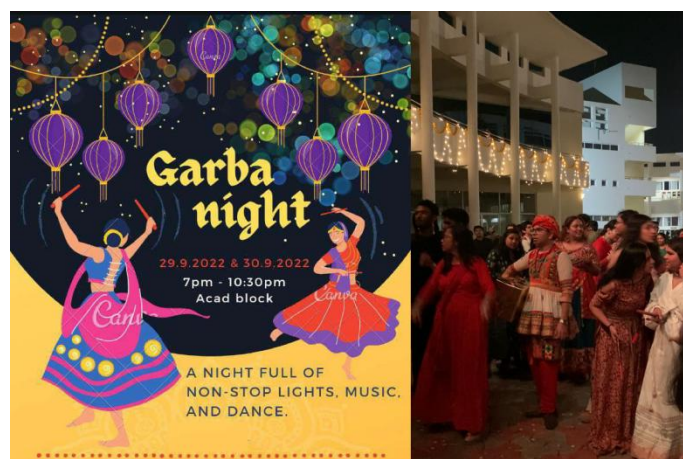
