




2. Ms. Sanjana S was declared as the Advocate at the Transatlantic Negotiation Competition 2022 from 1st to 3rd April 2022.

Events Organised in SLSH

Guest Lecture Series:-

1. A Guest Lecture on Copyrights in Industrial Design was organised from April 4th to 6th 2022 for the students of batch 2019-24. The guest speaker Ms. Shreya Bajpai, Specialist in IPR and an Assistant Professor at Amity University. She engaged the students with the practical as well as theoretical aspects of protection of various industrial designs under the ambit of the Designs Act and the Copyright Act.



2. A Guest Lecture on Start-ups and Information Technology Laws was organized on April 11th and 12th 2022 for the Students of batch 2017-22. The Guest Speaker Mr. Sushanth Samudrala, CEO of Sushanth IT Law Associates, who spoke on the practical applications of Start-ups and Entrepreneurship laws. The Lecture also helped the students to look into specific provisions under the Information Technology Act 2000 that are required for Startups and also examined the terms and conditions of relevant agreements.

- 4. A Guest Lecture on Cyber Crimes and Financial Frauds was organized on April 11th, 2022 for the Students of batch 2017-22. The Guest Speaker was Mr. Pankaj Dhotre, Security and Operations Specialist CBRE, who discussed the practical applications of Financial and Systemic Frauds. The lecture helped the students to look into the rising cases of cyber frauds and how to practically deal with such cyber frauds. It also gave students in-depth knowledge about the legal aspects of the same.
- 5. A Guest lecture on "Data Protection, Security and Privacy" was organized for the IV year students on 26th April 2022. The resource person was Mr. Gautam Busi, Partner at Tempus Law, Hyderabad. The session was extremely informative and interactive as the resource person discussed the various nuances of data protection and security in India with examples and compared the same with the International scenario.



CENTRES/CELLS and their Endeavors:

1. The Centre for Criminology and Criminal Justice, SLS Hyderabad organised a webinar on the topic "Oppression of underprivileged classes in criminal cases" where Justice Chandru, retired Judge of the Madras High Court was the guest speaker. Justice Chandru spoke at length about the global overview of police atrocities while referring to the Miranda rights in the United States. He emphasized on how these rights have been discussed in the Indian Bombay Blast case where the court opined that Miranda rights might not be relevant in cases of terrorism. He also shared his insights on police brutality with real-life examples. The session threw valuable light on the criminal justice system and the issues revolving around custodial deaths along the lines of caste, class, and gender.



2. The Centre for Specialisation in Cyber Law Studies (CSCLS), SLSH, conducted the 2nd Edition of its National Seminar on the theme Cyber Security and Sovereignty with an objective to create dialogue and insightful discourse around the very important subjects of cyber-security and the cyber sovereignty of nations and international contexts. The Seminar was held on 9th April 2022 with the inaugural ceremony being graced by Mr. P V Dinesh, Co-Founder, Live Law as the Chief Guest, Mr. Sahil Ahmad, Assistant Manager, Data Privacy at M&G plc as the Guest of Honour, and other esteemed panellists and participants.



3. The Alternative Dispute Resolution Society (ADRS), Symbiosis Law School, Hyderabad conducted a Two-Day National Symposium on Mediation in collaboration with Hyderabad Arbitration Centre with a distinguished panel consisting of eminent personalities across the field of ADR. The panel on Day 1 discussed at length "The draft Mediation bill" Panel deliberated upon the various aspects of the bill and the proponents and both long-term and short-term effects on the Indian Litigation system. The exchange of insights amongst the panel regarding the bill clarified various nuances involved in developing a mediation culture in India. On Day 2, the panel delved into the essentials of "The Singapore Mediation Convention". The learned panel extensively analyzed the nature of the convention and how being a party to such a modal agreement has influenced India.



4. The Center for Specialization in Immigration and Citizenship Laws (CICL) of Symbiosis Law School, Hyderabad, conducted a panel discussion on the topic "Russia's Invasion of Ukraine and its impact on Refugees and Immigration Laws". The speakers for the event were Mr. Akshay Kashyap, Partner at Kashyap and Associates (LLP), and Mr. GV Rao, Senior Advocate, Supreme Court of India. Important topics addressed throughout this session pertained to Western action against Russia's invasion of Ukraine, the role of the European Union, possible consequences for Russia on account of violation of international human rights laws.






