Workshop on "Legal Challenges with Artificial Intelligence and Privacy" on the occasion of Cyber Jagrookta Diwas on 5th August 2023.

The Centre for Specialisation in Cyber Law Studies, SLSH hosted a Workshop on "Legal Challenges with Artificial Intelligence and Privacy" on the occasion of Cyber Jagrookta Diwas on 5th August 2023. Mr. Sameer Avasarala, Senior Associate at Lakshmikumaran and Sridharan, who predominantly works in the Technology, Media and Telecommunication Law (TMT) space, specialising in data privacy and information technology laws invited as a resource person. He spoke about the evolution of legislation on data protection in India, and the current data protection schemes, and the various features of the Digital Personal Data Protection Bill, 2022. He discussed the concerns arising from using artificial intelligence (AI), like privacy violations, bias and discrimination, incorporation in the healthcare sector, and surveillance.

The session focused on Consumer Awareness and Fundamental Rights for the students of classes VI-IX. The event was part of the "2nd Prof. V.S. Mallar Memorial Legal Aid Competition, 2023," organized by the Centre for Environmental Law, Education, Research and Advocacy, National Law School of India University, Bengaluru.

The members of the Legal Aid Centre are divided into two groups and provide Consumer Awareness to the students on topics like identifying vegetarian marks, checking manufacturing dates, understanding rights as consumers, and seeking redressal. They also explain the Constitution of India to the students in other Fundamental Rights sessions, focusing on different articles.



Interaction with Street Vendors:-

The students of the Legal Aid Centre of Symbiosis Law School, Hyderabad, interacted with various street vendors in Mamidipally (near the vicinity of the college) on 20th August 2023 and in Hitech City and Kukatpally on 27th August 2023 with the aim of understanding the problems faced by each of these vendors, suggesting probable solutions to the same and spreading awareness about various government schemes, initiatives and legal requirements that are pertinent at both the Central and the state level. The team also introduced the vendors to a plethora of government initiatives for the benefit of street vendors and hawkers, including PM SVANidhi Yojana, DAY-NRLM, PMMY and the beneficial provisions of the Protection of Livelihood and Regulation of Street Vending Act,2014.
