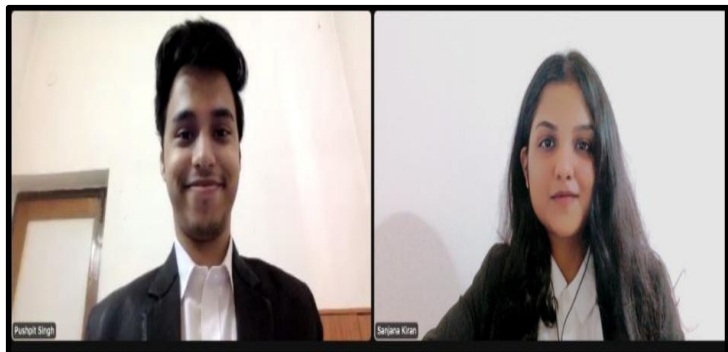

1. The Student Council of Symbiosis Law School, Hyderabad initiated a virtual Alumni Talk Series in the month of May 2022 wherein former students of SLSH were invited to interact with the students and guide and mentor them, besides sharing their experiences on a variety of topics. The first session of the series was held on 1st May 2022 wherein Ms. Shruti Ganguly (Batch: 2016-21) and Mr. Navneet Dogra (Batch: 2016-21) spoke to the students on the topic "Introduction to Law School," and guided the fresher students about the ways in which one should utilise their time at the law school.

The second session of the series was conducted on 7th May 2022 wherein Ms. Sindhu Akella (Batch: 2015-20) and Ms. Udepta Choudhary (Batch: 2016-21) guided the students on various aspects relating to academics at Law School. The sessions were attended by students from across batches and found them to be engaging and insightful.



2. The Student Council of Symbiosis Law School, Hyderabad organised one-of-a-kind entrepreneurship and legal crisis competition "IDEATE" on 8th May 2022. The object of the competition was to encourage students to think differently, thereby testing their problem-solving, analytical, and oratory skills. The participants posed as innovators to a unique product allotted to them which was in turn pitched by them to interested

investors. The competition consisted of a written submission round and an oral round. The best performers were duly awarded prizes and certificates.

students to become earth buddies and undertake a certificate course that revolved around saving the soil movement.

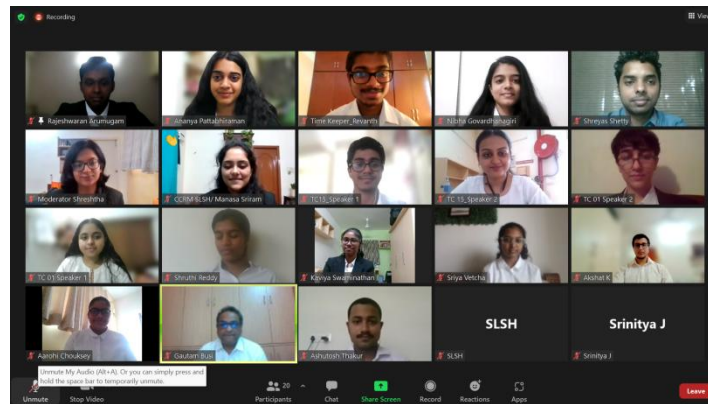

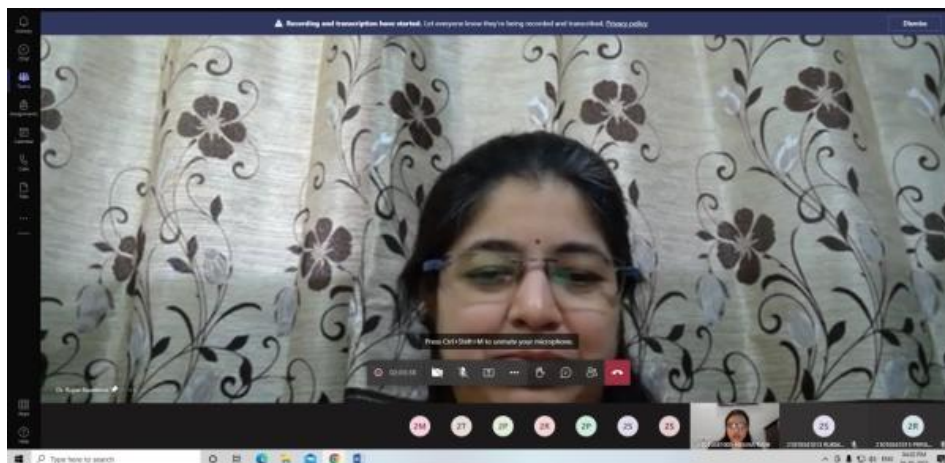
