Activities & Events at SLSH

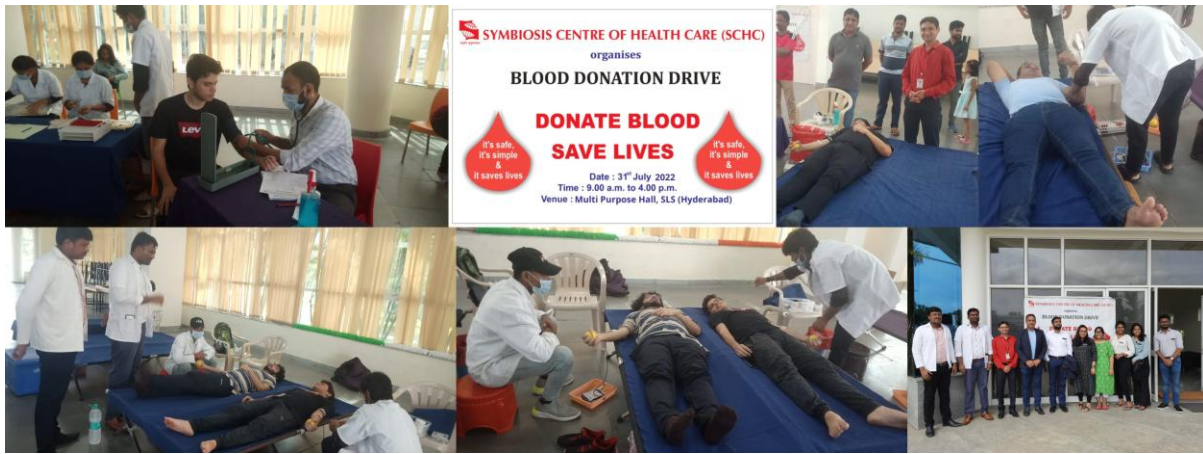
1. The Faculty, Staff and Students along with Dr. Santosh Aghav, Director, SLSH and Dr. Anuradha Binnuri, Deputy Director, SLSH viewed the live telecast of the address delivered by Hon'ble Prime Minister of India, Shri Narendra Modi at the 3-day Education Summit "Akhil Bharatiya Shiksha Samagam" on 7th July, 2022. In his address, PM Modi highlighted that the National Education Policy (NEP) 2020 enables the youth to find solutions to problems of the world through a modern education system with Indian ethos. He also emphasized that the focus should be on making our education system such that we create human resources that are needed for the country to take it forward.



2. Contemporary Lawyering core course was conducted for the students of 2019-24 batch between July 25th and 30th. Five topics ie. Setting up of values, Regulation of Emotion, Multicultural Sensitivity, Counseling Skills Development, Cognitive Behaviour Analysis: A system of psychotherapy. The andragogy chosen was the use of worksheets that facilitated outcome based education on each of these topics was used as an experiential teaching aid. This supplemented the pre-class survey where 58 respondents from the student batch expressed their interests and learning areas from the course. Session outcomes shall be measured after assessments. Thus course outcomes and how they equip students to apply session outcomes to their future contemporary lawyering practices shall be measured.
