**WHEREAS**, the University has framed its [Prevention, Prohibition and Redressal of Sexual Harassment of Employees and Students in the University and its Constituent Institutes/ Departments/ Sections/ Offices/ Workplaces] Rules, 2019 vide Notification No. SIU/ U-28/ 821 dated 16<sup>th</sup> May, 2019 in accordance with the UGC (Prevention, Prohibition and Redressal of Sexual Harassment of Women Employees and Students in Higher Educational Institutions) Regulations, 2015;

2] **AND WHEREAS**, in accordance with Chapter 3 of the said Rules of the University, Internal Committee at Off Campus Centre of Symbiosis International (Deemed University) at Hyderabad was constituted vide Notification No. SIU/ U-28/ 833 dated 24<sup>th</sup> June, 2019;

3] **AND WHEREAS**, the tenure the Internal Committee at Off Campus Centre of Symbiosis International (Deemed University) at Hyderabad constituted vide Notification No. SIU/ U-28/ 833 dated 24<sup>th</sup> June, 2019 and reconstituted from time to time has come to an end on 23<sup>rd</sup> June 2022;

The term of the office (tenure) of the members of the Internal Committee at Off Campus Centre of Symbiosis International (Deemed University) at Hyderabad shall be for a period of three (3) years ie., from 24<sup>th</sup> June, 2022 to 23<sup>rd</sup> June, 2025.

The tenure of the student member(s) shall cease as and when they cease to be the student of the Institute/ Department/ University.

The tenure of the faculty member(s) and non-teaching employee(s) shall cease as and when they resign from their services or is transferred to another Campus/ Location.
